This is a general agreement for the establishment of a collaborative academic effort between the Department of Physics, Vivekanand College, Kolhapur (VCK) (affiliated with Shivaji University, Kolhapur), Maharashtra, India, and the **Department of Physics, Devchand College, Arjunnagar (DCA). Tal: Kagal, Dist: Kolhapur, Maharashtra, India**

It is hereby agreed that these two institutions shall cooperate on the following:

**1. Objectives of the MoU:**

- a) To Exchange faculty, students, and research scholars at both Institutions.
- b) To share infrastructure (equipment's) & library facilities for education & research.
- c) To organize joint training programs, seminars, workshops & conferences.
- d) Engage in research activities and submit joint research proposals to various funding agencies.
- e) Joint supervision of UG/PG thesis as per institutes' norms.
- f) To promote and enhance academic interest between institutions.

**2. Implementation**

- a) In order to carry out the above-mentioned activities, detailed plan of the academic cooperation, strategies for interactions, and mechanisms leading to the exchange of faculty and students shall be formed through consultation between the two institutions and expressed in



academic agreements.

- b) Both institutions shall agree to seek financial support for the mutually agreed cooperative activities as defined above from appropriate agencies of their respective government and other agencies.
- c) Promote appropriate joint research projects and joint interdisciplinary courses of study i.e. a research in the field of science and technology will be carried out in collaboration with mutual consents of both the institutes.
- d) This Agreement will be effective for five (5) years from the date of signing. This Agreement will continue to be operative or renewed automatically as long as either party gives notice of termination to the other.

### 3. Co-ordination:

The following arrangement is suggested for the coordination of MoU. Each of the Institution (VCK and DCA) shall appoint one faculty member from each side to coordinate communication and implementation of the activities. Both members will identify the ways to strengthen the cooperation between two institutes.

### 4. Duration of MoU:

This MoU, unless extended by mutual written consent of the institutes, shall expire FIVE years after the commencement. However, on review, the MoU shall be extended for another FOUR years by mutual consent.

### 5. Funding:

This MoU does not commit any funds.
