Item no. 2 To approve the minutes of IQAC and CDC.

The meeting of IQAC was held on 05.06.2023. The minutes of this meeting were read out by IQAC Coordinator Dr. S. M. Joshi and confirmed by the members. The achievements of students-teachers and activities conducted during the academic year 2022-23 by IQAC were reported.

Dr. B. M. Hirdekar suggested that these college activities should be broadcasted on the PM portal as well as the media like Linked In and Instagram.

The meeting of College Development Committee was held on 10.01.2023. The minutes of the meeting were read out by Prin. Dr. R. R. Kumbhar. He informed about the infrastructural renovations and constructions going on for new Microbiology lab, new ladies room, new labs and classrooms for Geography, BCA and B.Sc. Comp. Sci. (Entire) department. Also, updates regarding newly started programmes and increased intakes of existing courses were informed. Principal sir also informed the members that new ads will be released for 27 vacant posts of teachers for Autonomous College only..

Dr. B. M. Hirdekar suggested that Science faculty departments should conduct guest lectures through MoUs and the professional courses should focus on increasing placements through industry resource persons. He further advised that while appointing new teachers, English language proficiency, digital proficiency and research background of the candidates be focused

Dr. H. B. Patil suggested that the college can establish an MoU with the CERUM Institute, Pune and appoint efficient staff for M.Sc. (Biotech).

The meeting of CDC was held on 18.08.2023. Its minutes were read and confirmed.

Item no. 3 To approve the minutes of Academic Council.

The meeting of Academic Council of the college was held on 13.10.2023. Its minutes were read by Prin. Dr. R. R. Kumbhar and were confirmed by the members.

Item no.4. To approve the minutes of Finance Committee

The meeting of Finance Committee was held on 10.10.2023. Minutes of the meeting were read by Prin. Dr. R.R. Kumbhar and confirmed by the members.

Item no.5: Any other matter with the permission of the Chair.

1. To discuss and decide about providing infrastructural facilities like computer labs for the newly proposed programmes of MBA (Master of Business Administration) and MCA (Master of Computer Application)

The proposed programmes MBA and MCA are to be started from the academic year 2023-24. The possibility of providing surplus computers from other departments of the college, initially, for the infrastructure of computer labs for these programmes was discussed.

It was resolved that from the departments of B.Sc. (Comp. Sci. Entire) (31 computers), BCA (9 computers) and Junior computer science and IT (65 computers), the excess computers will be additionally used for these new labs.

2. To inform about the status of Empowered Autonomy

Principal Dr. R. R. Kumbhar informed the members about the college being conferred with the status of Empowered Autonomy by Shivaji University as per provision in MPUA-2016 Sec. 123 from July 2023.

3. To send proposal for Unitary University

Principal Dr. R. R. Kumbhar informed that a proposal will be sent for acquiring the status of Unitary University after the 4th Cycle of NAAC is completed.



4. To inform about PM-USHA proposal

It was informed that a proposal of more than Rs. 6 Cr. has been sent for PM-USHA. The budget related to new infrastructure (new library, extension of ladies hostel), renovations, laboratory equipment and soft components was presented by the Principal.

5. To inform about the preparations for facing NAAC in the fourth cycle

The documentary preparations for submitting IIQA and SSR of the college under the fourth cycle of NAAC are undergoing. The members were informed about the progress as well as hurdles in this regards.

6. To inform about research lab establishment proposal

The permission to send proposal for research lab establishment was unanimously granted by the members of Governing Body.

It was suggested that as the amount of seed money from college for the teachers' research projects was increased, it is necessary to timely check the progress of the projects; and analyse the worth of research outcomes.

7. To discuss the stakeholders' feedback

As the college has developed a sound feedback system, every year online as well as offline feedback from various stakeholders is collected and analyzed; and proper action is taken. It was suggested to the incharge officer of feedback (Ms. Samiksha Farakate) that major feedback from stakeholders be brought to the notice of the management timely.

As there was no other matter to discuss, a vote of thanks was proposed by Prin. Dr. R. R. Kumbhar and the meeting ended with the permission of the Chairman.
